Headington Market Relocation to Quarry Hollow Park, OX3 8NX

Risk Assessment relating to relocating and re-opening the market after the Covid19 closure. Updated for Lockdown 3/5th January 2021.

Background

The operators of Headington Market (Headington Action) took the decision on 22 March 2020 to suspend the market due to the narrow nature of the high street location and difficulty in enforcing social distancing measures until the risk was deemed to have reduced significantly. On 23rd March the Government banned outdoor markets except for food. On 25th May the Government announced that all outdoor markets could resume trading from 1st June 2020 with the right safety measures in place. Headington Market remained closed due to the site restrictions mentioned above. However, a temporary site was identified to accommodate a reduced sized market in the Council managed Quarry Hollow Park to which the Council gave consent. The park comprises of play areas, slopes and mounds with a flat tarmac area to one side. There is a 3-metre-wide sloped road down from Quarry Road to the tarmac area and a path exiting to Quarry Hollow Road. Both the entrance and exit have wooden gates. The area around the site comprises roads, houses, a village hall, etc.

On Thursday 5 November a second lockdown "Lockdown 2" commenced with similar restrictions to the first lockdown. Headington Action have consulted with Oxford Environmental Health and taken account of the latest Government rules, law and advice (https://www.gov.uk/guidance/new-national-restrictions-from-5-november) and considered any new or further risks before deciding on trading during lockdown 2. In line with most other outdoor markets we have decided to continue to trade in a safe environment to support both customers and traders, providing the permitted range of food, plants and restricted essential non-food products. This risk assessment takes account of latest rules. The market is in a controlled environment and has been trading safely since 4 July 2020. Online & delivery is available from key stalls and pre-order & click & collect encouraged. All traders will wear masks and customers have been asked to wear masks. Social distancing will be enforced by trained stewards.

From 5th January 2021 a third National lockdown commenced "lockdown 3". Laws and guidance are very similar to the other national lockdowns in terms of the market continuing to open with some differences & noting increased rate of infection with the new strain/s and need for distancing & spacing. Therefore the market will continue to open as below:-

Key Points

• Traders are permitted to travel as they cannot work from home. They are also providing food & essential supplies

- Customers are permitted to leave home for food & essential supplies
- Stewards are permitted out "You can leave home to offer voluntary or charitable services". They will also be shopping for food whilst there
- Primarily Food stalls with one or two essential non-food stalls (as per permitted essential products).
- Encourage pre-order & click & collect.
- Hot food coffee and Greek stall located away from main market and plenty of space for queuing. Takeaway only as permitted.
- Spike posts and bunting ropes will create a barrier enclosing the Market area away from the other public areas
- Controlled Entry point for queuing entry will not be permitted to a group size above limit
- Traders will wear masks or shields. Shoppers will be asked to wear masks. Free masks are available
- Traders will offer contactless payment
- Anyone showing signs of symptoms will not be permitted
- 40m of entry queuing Market entry. Splits into one queue for bread and one for other
- Manned Sanitise station (we squirt the gel/public do not touch the bottles)
- Entry to Market trading area numbers controlled to maintain correct distancing
- One-way route around market trading area. Exit only route provided
- Social distancing enforced additional stewarding & measures to take account of new virus strain
- Stewards will be posted to manage the queuing areas, sanitise, entry & exit areas, trading area social distancing and hot food areas.
- The community police team regularly attend
- Anchor stalls of bread, vegetables and eggs have been positioned to allow for additional queuing space and segregation. The bread queue is outside the trading area to allow for the biggest queue and for people to get their bread first.

This risk assessment is to show the issues we have considered and the measures we have taken to allow us to trade as safely as possible at the current time in the temporary location, both in terms of our general operation and in light of Covid19 Government & Local Authority advice & regulations.
